# 1940s WEEKEND

## Conditions of Entry

1. Each exhibitor is expected to share responsibility for the safe and smooth running of this event. In particular:
  - a. Exhibitors should immediately report any accident or other incident to the AVR Duty Manager and must be able to describe what happened and the names of the individuals involved, be they visitors, contractors or anyone else;
  - b. Exhibitors should take seriously any complaint made to them and report these promptly to the AVR Duty Manager.
2. Trains will be in operation during the day and exhibitors, like visitors, must follow the railway safety rules, in particular keeping only to marked public rights of way and track crossing places. In no circumstances should any exhibitor walk on the railway track.
3. All exhibitors must be insured against third party risks, if appropriate to the attraction concerned.
4. All exhibitors must pay full regard to the AVR Duty Manager's instructions and conduct themselves in a manner which does not inconvenience visitors or other contractors at any time.
5. Exhibitors must not charge customers for their attractions. (Any exceptions to this rule will be agreed in advance and clearly advertised at the event.)
6. Because we are in a residential area, we do not allow any gunfire or explosions at this event.

## Vehicle Exhibits

7. All vehicles must be insured against third party risks and fully licensed and tested in accordance with the regulations applicable to that type of vehicle for road use. The organisers reserve the right to ask for proof of these items.
8. Owners must ensure that all drivers are qualified in law to handle the class of vehicle exhibited.
9. No exhibit shall be left running unattended. All unattended vehicles shall be left securely braked and/or chocked.
10. A speed limit of 10 M.P.H. shall apply to all vehicles, including modern vehicles in all areas off the highway.
11. All entrants must pay full regard to marshals' instructions and conduct themselves in a manner which does not inconvenience other road users or other persons at any time.
